### Expenses

We opened as a non-profit organization on February 23, 2018. We had many expenses in 2018 and in 2019. We had overhead costs such as purchasing insurance for the organization's members and directors (\$1,493.17), branding items such as business cards, binders, shirts, office supplies, signs, etc (\$1,855.36). Our major expense pertained to our 1<sup>st</sup> Annual Gala held in March (\$19,983.42).
